Privacy Policy

Chicago United for Equity knows that you care how information about you is used and shared. To ensure that you understand our commitment, we provide this Privacy Policy explaining our online information practices and the choices you can make about the way your information is collected and used on this website. Collection of information

First, we do not collect personally identifying information about you (such as name, address, e-mail address, telephone numbers and/or credit/debit card information) when you visit our site, unless you choose to voluntarily provide such information to us. The information you willingly provide is retained and used in accordance with existing laws, rules, regulations, and other policies.

You can visit our site without telling us who you are or revealing any personally identifiable information about yourself. If you choose not to provide personally-identifying information, we may not be able to fulfill a request that you make or otherwise assist you.

Purpose of information collection

Personal information that you choose to disclose is collected on an individual basis for various purposes, such as registering to receive e-mail newsletters or other materials, requesting further information from us about projects and services, donating to us, making requests, submitting a form on our website, or simply asking a question. We ask for this information so that we can process your request, register you for an event, return a message, etc.

The way we use collected information

We do not share this information with outside parties except to the extent necessary to complete that order.

We use return email addresses to answer the email we receive. Such addresses are not used for any other purpose and are not shared with outside parties.

Sharing of information

Except as might be required by law, we will never share any information we receive from you, including your email address, with any outside parties. We do not sell, rent, trade, or give away email addresses.

Anonymous information is collected for every visitor to this site. This includes pages viewed, date and time, and browser type. IP addresses are not stored but are temporarily used to

determine domain type and, in some cases, geographic region. We do not make any association between this information and a visitor's identity.

Automatic information

When you visit our website, our servers make a log of basic information corresponding to the sites and pages you have visited. This information is stored primarily to track the effectiveness of our website and individual sections and pages within it.

How does this site use cookies?

Cookies are simple text files stored by your web browser that provide a method of distinguishing among visitors to the website. Chicago United for Equity uses cookies to identify your browser as you visit pages on our website. Cookies created on your computer by using our website do not contain personally identifiable information and do not compromise your privacy or security. Cookies allow Chicago United for Equity to gather anonymous information and to keep track of your registrations for events.
